



Privacy Policy

Keeping your information private is a priority for KonnectMD, LLC and its affiliates. To enable us to provide our membership plans, we need to collect certain personal information from you. It is sometimes necessary to share that personal information with others to provide our services to you. However, we want to emphasize that we are committed to maintaining the privacy of this information in accordance with law. All individuals with access to personal information about our customers are required to follow this policy.

This privacy notice informs you of what personal information we collect about you and how we treat that information. Its purpose is to answer questions you may have regarding our treatment of your personal information and reassures you of our dedication to keeping your personal information secure.

Information We Collect

We collect non-public personal information about you from the following sources:

- Information we may receive from you on applications or other forms such as your name, address, payment instructions, and Social Security Number (SSN for Konnectors, only).
- Information you may provide during visits to our website including IP address and cookies.
- Information about your transactions, interactions or communications with us, our affiliates or others.

KonnnectMD does not collect, nor do we ever have access to your private medical records. Your private medical records are only handled by our healthcare provider partners, Healthcare One, through their HIPPA compliant, secure system.

Information We Share

We do not disclose any non-public personal information about our Konnectors or Patients, past or present, to any non-affiliated entity except as described below and otherwise permitted by law.

When information is shared with companies that perform services on our behalf, we protect against the subsequent disclosure of that information with a confidentiality agreement and/or other protective measures.

In no event do we disclose your personal information to companies that will use that information to contact you about their own products or services.

Konnectors, past or present, are strictly prohibited from disclosing, sharing, or selling the personal information of their downline Konnectors. All downline information is proprietary and owned exclusively by KonnectMD, LLC and is not the property of any Konnector, past or present.

Our Security Procedures

We restrict access to non-public personal information to those persons who need such information to provide products or services to you. We maintain physical, electronic and procedural safeguards that comply with federal regulations to protect your non-public personal information. We keep information for as long as is necessary for our business purposes and will dispose of all information in appropriate ways according to law and our company practices.

Use of Cookies

KonnectMD may use data collected from our website, including history data or cookies, in accordance with the Privacy Policy. Most of the cookies are functionality cookies which are used to recognize repeat visitors to the website. Analytics cookies are used to monitor how visitors use our website to give us understanding of what content visitors are viewing and where they spend time accessing it. Our website does not acknowledge Do Not Track settings. Third parties may also use cookies.
